

AWARD ON AGREED TERMS

- 1. On 19 January 1982, the GOVERNMENT OF THE UNITED STATES OF AMERICA on behalf of NORTHERN VIRGINIA COMMUNITY COLLEGE ("the Claimant") filed a claim against THE GOVERNMENT OF THE ISLAMIC REPUBLIC OF IRAN ("the Respondent"), seeking payment of charges owed for student tuition and fees. 1
- 2. Pursuant to Article 34, paragraph 1 of the Tribunal Rules, a Joint Request was filed on 1 August 1989, signed by the Deputy Agent of the Government of the United States of America on the one hand and by the Agent of the Government of the Islamic Republic of Iran on the other, requesting that the Tribunal render an Award on Agreed Terms recording and giving effect to the Settlement Agreement in this Case, dated 5 April 1989 between the Ministry of Defence of the Islamic Republic of Iran and Northern Virginia Community College, which provides for certain reciprocal obligations of the Parties thereto.
- 3. Article 1 of the Settlement Agreement provides, <u>inter</u> alia, for the Claimant to be paid the sum of U.S.\$508.
- 4. Copies of the Joint Request and the Settlement Agreement are attached hereto.
- 5. In view of the fact that the provisions of the Settlement Agreement fulfill the requirements for the issuance of

Subsequent to a request by the United States in its Supplementary Statement of Claim of 10 October 1986, by Order of 3 November 1987, the Tribunal decided that the Claim was an official Claim under Article II, paragraph 2, of the Claims Settlement Declaration, as the Claimant is an entity controlled by a political subdivision of the United States, as defined in Article VII, paragraph 4, of the Claims Settlement Declaration. The Case number was changed accordingly from Case No. 12438 to Case No. B73.

an Award on Agreed Terms, the Tribunal accepts the Settlement Agreement in accordance with Article 34, paragraph 1, of the Tribunal Rules.

6. For the foregoing reasons,

THE TRIBUNAL AWARDS AS FOLLOWS:

- (a) The Settlement Agreement filed with the Joint Request is hereby recorded as an Award on Agreed Terms, binding on the Parties in full settlement of the entire Case.
- (b) THE GOVERNMENT OF THE ISLAMIC REPUBLIC OF IRAN on behalf of the MINISTRY OF DEFENCE OF THE ISLAMIC REPUBLIC OF IRAN shall pay NORTHERN VIRGINIA COMMUNITY COLLEGE, the amount of Five Hundred Eight United States Dollars and No Cents (U.S.\$508.00), which obligation shall be satisfied by payment out of the Security Account established pursuant to paragraph 7 of the Declaration of the Democratic and Popular Republic of Algeria of 19 January 1981.
- (c) This Award is hereby submitted to the President of the Tribunal for the purpose of notification to the Escrow Agent.
